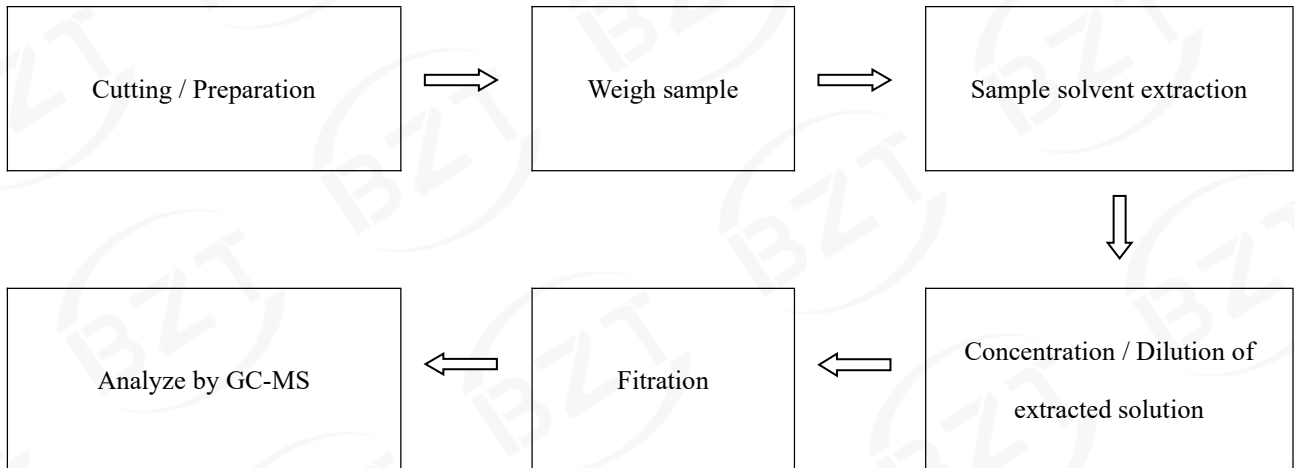
Nonmetal material
